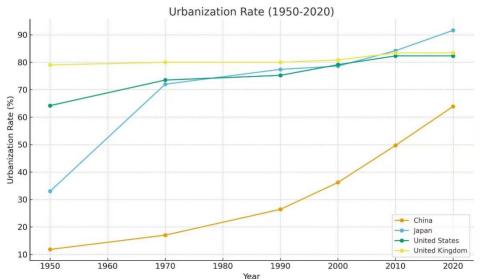
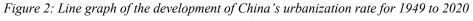
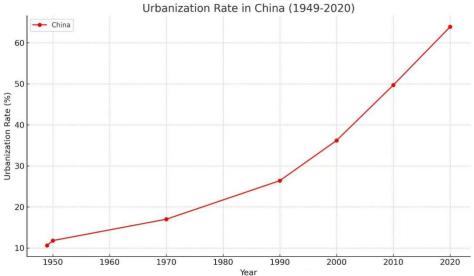


Figure 1: Urbanization rates of major countries worldwide, 1950–2020

It has made a significant contribution to increasing people's well-being and people's livelihood. However, many problems have also been revealed. As shown in (Figure 1) and (Figure 2).

Notably, the number of college graduates in China is increasing every year. In 2025 alone, there will be 12.22 million graduates, and the formal sector obviously cannot absorb all the people. Flexible employment is important not only as a transitional plan but also as an emergency plan. distribution channel. Chinese government has repeatedly recognized and supported its development. Mass entrepreneurship and innovation encourage people to invest in this emerging industry.

3.2 Development Issues

In the Dialectics of Nature, Engels mentioned, "The development caused by the contradiction or the negation of the negation—the spiral form of development." The rapid development of urbanization inevitably presents some difficulties. First, the current social comparison has reached a consensus. Importantly, the rights and interests of workers cannot be fully protected. The crowding-out effect should not be ignored. If the government uses only administrative means to increase the minimum wage of employees, enterprises, especially micro, small and medium-sized enterprises, will carry out large-scale wagering to reduce costs. Through permanent layoffs, further reductions in workers' protections and benefits, or the extension of working hours, workers will be brought into a more unstable state. In addition, a reduction in private investment will reduce the market for informal employment and intensify competition. There is even vicious competition. The impact of the crowding out effect on employment is shown in Figure (3).

3.3 Causes of the Problem

Informal employment is partly due to the over-exploitation of working conditions that prompt workers to transfer in, the contradictions between low wages, wage arrears, overworking quotas, a strict factory system and family responsibilities. "Sanhe Dashen" as the theme of daily work completion in China In microcosm, they scoffed at the factory system, fought against commoditization, and declared that they would protect their surplus value. This reflected the desire of the workers to seek freedom and a better life, but the daily end-ofthe-day workers were not the fundamental solution to the problem. In fact, in the daily end-of-day workers, the competition among workers, the cooperation between day-to-day workers and intermediaries, and in the process of unknowingly creating a labor force commoditization system, a harsh living environment, and poor living habits are all the tragedies of the people at the bottom under the ever-changing cities, and this is a clear manifestation of the plight. Simple deportation and supervision are not enough to make many "sanhe gods" disappear. The plight and solutions of informal workers require the joint efforts of the whole society. Finally, informal employment has long been associated with words in society, such as not doing proper jobs and being unstable, with a low sense of social identity. To solve the plight of informal workers, the state and society should not only solve the problem from the material and economic points of view but also pay attention to their spiritual and civilized lives. Their occupational dignity should receive attention. The following table (Table 1) indicates the work and living difficulties of migrant workers, an important theme of informal employment (Wan & Liu, 2007).

Other behaviors are accepted and addressed in a timely manner to effectively safeguard the professional dignity and legitimate the rights and interests of informal employees.

4. Conclusion

This thesis starts with the background significance of informal employment, discusses the necessity of studying informal employment from theory and practice, discusses its prospects and highlights the predicament from data and facts.
